COURT VISIT Report

Court Visits were organized by the Bharath Institute of Law, Bharath Institute of Higher Education and Research, to the High Court of Madras, Chennai on 5th, 6th and 12th November 2019. Providing students an exposure about gaining knowledge about adjudication process was the aim of the Court visit. Mr. J. Lalith Kumar, Assistant Professor has accompanied students for the Court Visit.

All the students had assembled at around 8.30AM in the university campus and departed to Madras High Court at 9.15 AM. They reached the destination at 10.30AM. High court visit started at 11.00 AM along with MR. C. Vishwanth, Advocate at Madras High Court. The students had an opportunity to interact with the Honorable judges and many learned advocates and the guiding advocate helped all the students to visit the various Courts in the campus.

The High Court Of Judicature at Madras, one of the three Chartered High Courts in India established at the presidency towns by letters patent granted by her Majesty Queen Victoria, bearing date of 26th June 1862, is the highest court in the state of Tamilnadu , exercising original Jurisdiction over the City of Madras and Appellate Jurisdiction over the entire State as well as extra-ordinary Original Jurisdiction, Civil and Criminal, under the Letters Patent and Special Original Jurisdiction for the issue of writs under the Constitution of India.

The Hon'ble The Chief Justice is the Head of the Judiciary with powers of administration of the High Court and of the Administration of Justice throughout the State. The Hon'ble Chief Justice is in charge of the general policy adopted in the Administration of Justice. The administration of Justice in the Civil and Criminal Courts in the districts constituted under the Civil Courts Act and the Code of Criminal Procedure
