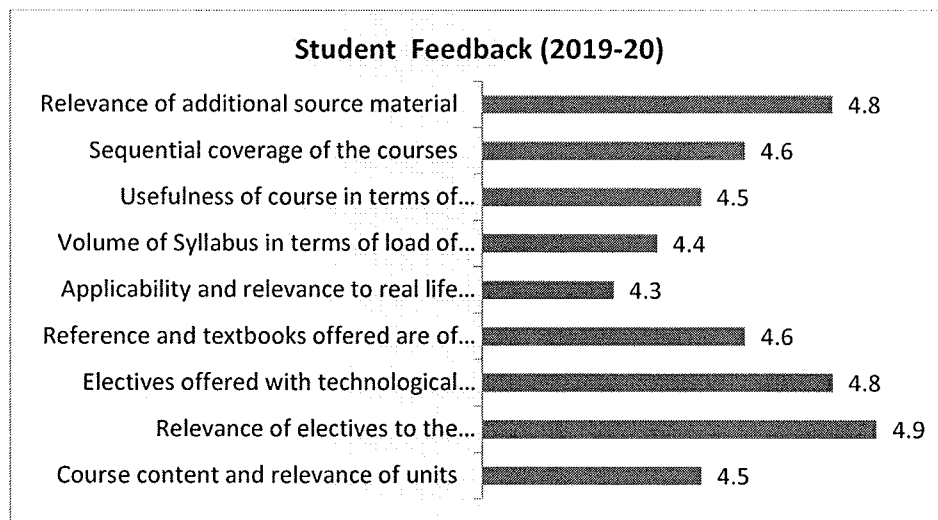


FEEDBACK REPORT – 2019 – 2020

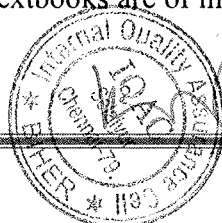

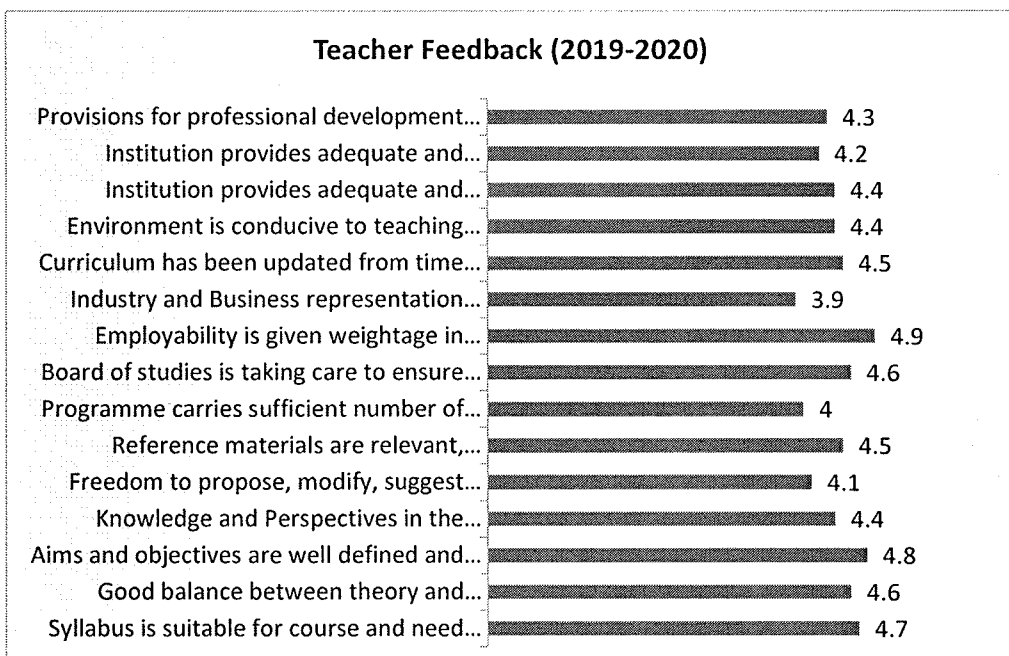
- The content offered in the course and relevance of units are satisfying (4.5/5)

- Relevance of reference and textbooks are of international recognition (4.6/5)



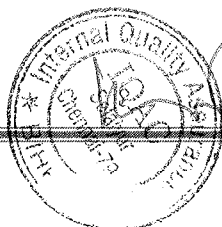
- The courses offered are more applicable and relevant to real life situation (4.3/5)

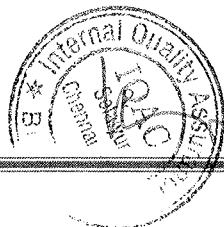
- The Syllabus covered is suitable for course and need based (4.7/5)
- There exists balance between theory and application in a vast manner (4.6/5)



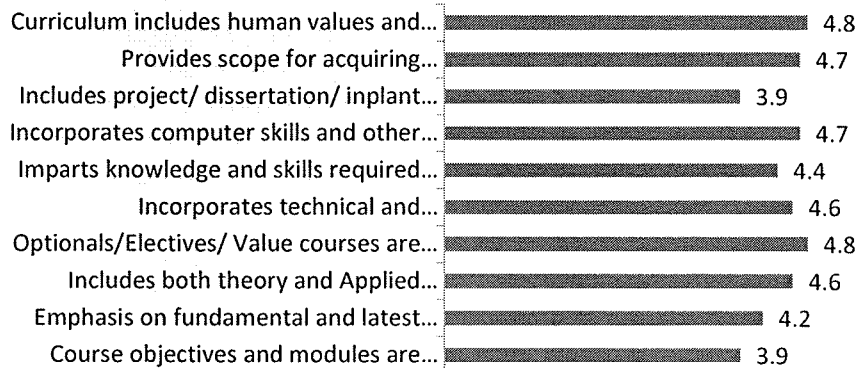
- The aims and objectives of the syllabi are well defined and clear to both teachers and students (4.8/5)

EMPLOYER FEEDBACK

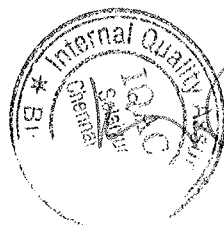

Employer Feedback(2019-20)

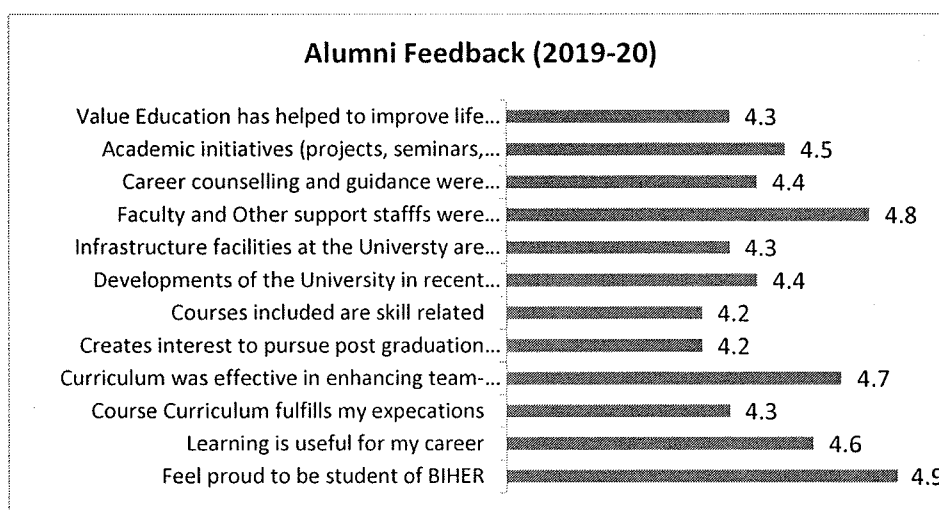


- Most of the employers feel that the course objectives and modules are defined and structured in a logical sequence (3.9/5)

- Curriculum includes human values and ethics (4.8/5)

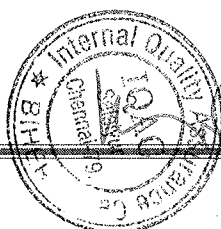


ALUMNI FEEDBACK

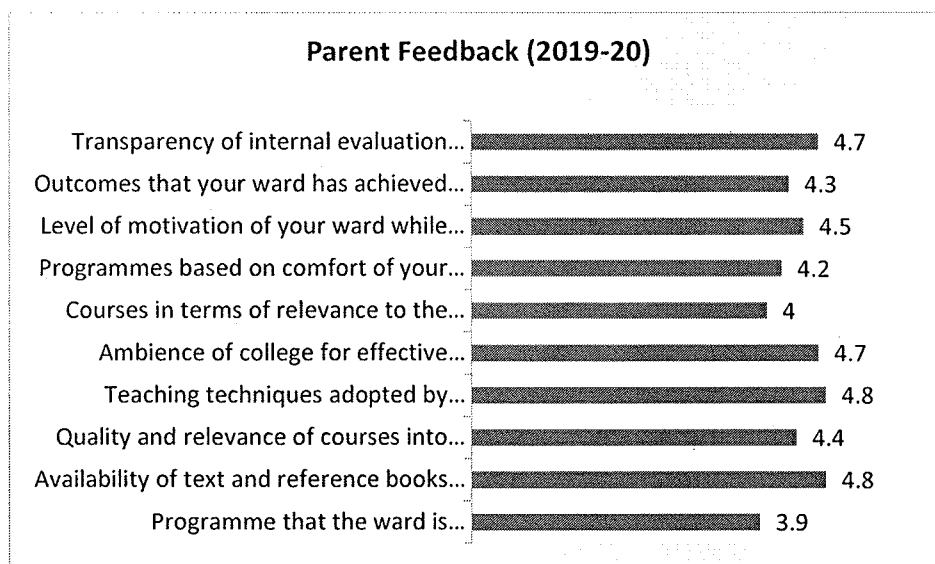
- The Alumni feel proud to be part of the Bharath Institute of Higher Education and Research (4.9/5)

- There are adequate infrastructural facilities offered at the institution (4.3/5)



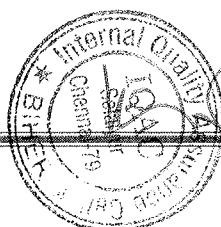
- The teaching and non teaching staffs offer extended support and are helpful and cooperative (4.8/5)

Action Taken Report

2019-2020

- The electives subjects list with respect to concern stream shall be sent to Board of Studies through Academic Council for upgradation with more pertinent elective courses.
- The upgradation of courses with more appropriate curriculum will be informed to Academic Council and a Review BOS Meeting with professional members will be arranged.
- The assignments having a theoretical and business importance will be asked to be provided by the subject course coordinators.
- Entrepreneurial skills, soft skills training, languages training and interpersonal training need to be organized for final years and first year students to increase the job potentiality in job market.
- The volume of syllabus is found to be more, it is found to be applicable and however, various methodologies of training will be executed to develop the learning process.
- Professors are advised to partake in more number of Faculty Development Programs, Seminars, Conferences and Workshops relevant to their Management courses, thereby enhancing their knowledge and exposure in the corresponding course.
- As per the suggestions received from the faculty feedback, the Management department will proceed with the procurement process of the new management books.
- Professors are recommended to implement various teaching methodologies available in the department and encourage the students to do in house projects.
- Management Students and faculties are directed to take part in Professional activities related to the area of interest.
- Relevant courses from the industry can be included in the curriculum and course objectives can be defined in a more active manner which will help and support students to enhance their skills.
- Recent developments in management and business concepts need to be incorporated in curriculum.
- More focus will be given on application oriented concepts so that curriculum will be taught in a well-balanced manner in the forthcoming semesters.
- Skills required for employment that is more specific for the job market should be developed.
